<b>Sexual Misconduct:</b> Sexual misconduct includes any behaviour of a sexual nature which is unwelcome (without consent), unreciprocated (not returned in kind) and which might create a stressful or intimidating working, studying or social environment.	We have a <u>Sexual Misconduct Policy</u> and process in place to ensure the safety of our community. It is the responsibility of ArtsEd to undertake an investigation into a breach of this Policy.	Sexual misconduct is not permitted in the ArtsEd community and everyone is expected to treat all members of the community with dignity and respect. <b>PREVENT &amp; Radicalisation:</b> Prevent is about safeguarding people and communities from the threat of terrorism. Radicalisation refers to the process by which a person comes to support terrorism and forms of extremism leading to terrorism.	ArtsEd is expected (by the UK Government) to have due regard for the need to prevent people from being drawn into terrorism and are required to protect all learners from the risk of radicalisation.
